Invitation

The Scandinavian Academy of Management (SAM) and the International Federation of Scholarly Associations of Management (IFSAM) are pleased to welcome you to SAM/IFSAM's VIIth World Congress in Göteborg, Sweden 2004.

IFSAM, the worldwide umbrella organization for academies and associations of management and business with an interest in scholarly work, has previously held IFSAM congresses in Tokyo (1992), Dallas (1994), Paris (1996), Alcalá de Henares (Spain 1998), Montreal (2000), and the Gold Coast (Australia 2002). The VIIth World Congress is hosted by SAM with members from the five Scandinavian countries (Denmark, Finland, Iceland, Norway and Sweden) and the School of Economics and Commercial Law in Göteborg. The Congress will be held at the Swedish Exhibition & Congress Center in Göteborg on July 5 – 7, 2004.

Early submissions are strongly encouraged. The deadline for reviewed submissions is the 31 December 2003. Papers received after this date will not be blind reviewed, but may be presented in special «work in progress» sessions.

The organising committee welcomes any suggestions regarding panel sessions, symposia, or additional streams. Please email your suggestions to ifsam@handels.gu.se. Submissions must be original, that is, not previously published or presented at a conference. Submissions imply that at least one of the authors will register for the Congress and be present at the time designated in the program.

An author may not submit more than two papers. Where two are submitted no more than one will be selected for inclusion in the program.



Details of Submission

- Research papers, poster papers, international symposia/panel proposals.
- Electronic submission by email; or diskette (MS Word or Word Perfect format, for PC); or hard copy.
- 1 if by email, 2 if by diskette, 3 if by hard copy
- 12 point, Times New Roman
- All submissions must include an English language copy, but if 3 or more papers are received in such other languages as: Chinese, French, and Spanish, sessions for these languages will be offered if practicable. The organisers cannot guarantee that all papers in a language other than English will be in the same stream.
- Maximum of 10 single-spaced A4 pages, exclusive of title page but including abstract, tables and figures, references and notes (3,000 to 5,000 words).
- The first page of the paper being submitted should clearly indicate: Paper type, academic stream the paper is to be considered under, the title of the article, the name(s) of the author(s), mailing address(es), email address(es), telephone and facsimile number(s). Please designate one author for all correspondence.
- The second page of the paper being submitted should contain the Title and the Abstract only, but no author identification.

- Attached tables and figures should be included at the end of the text of the paper when determining the length of the paper, as stated above.

Review process

All submissions will be subject to a blind review process. This process will be conducted by your Program Chair in cooperation (when possible) with National Program Chairs. There will be at least two reviewers for each submission. Submissions will be published in the Congress proceedings only if at least one of the authors attends the Congress.

Acceptances

Notification of acceptances will be sent when the review process is completed.
