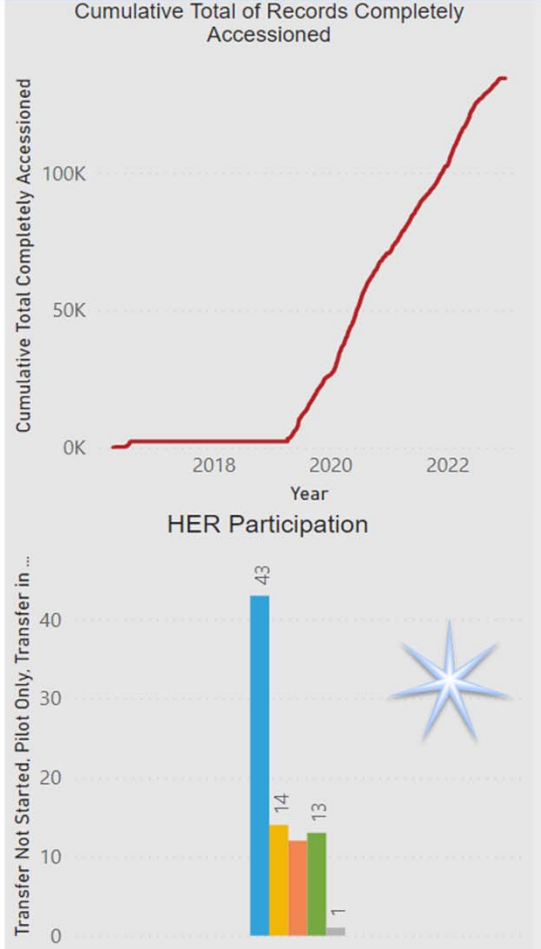
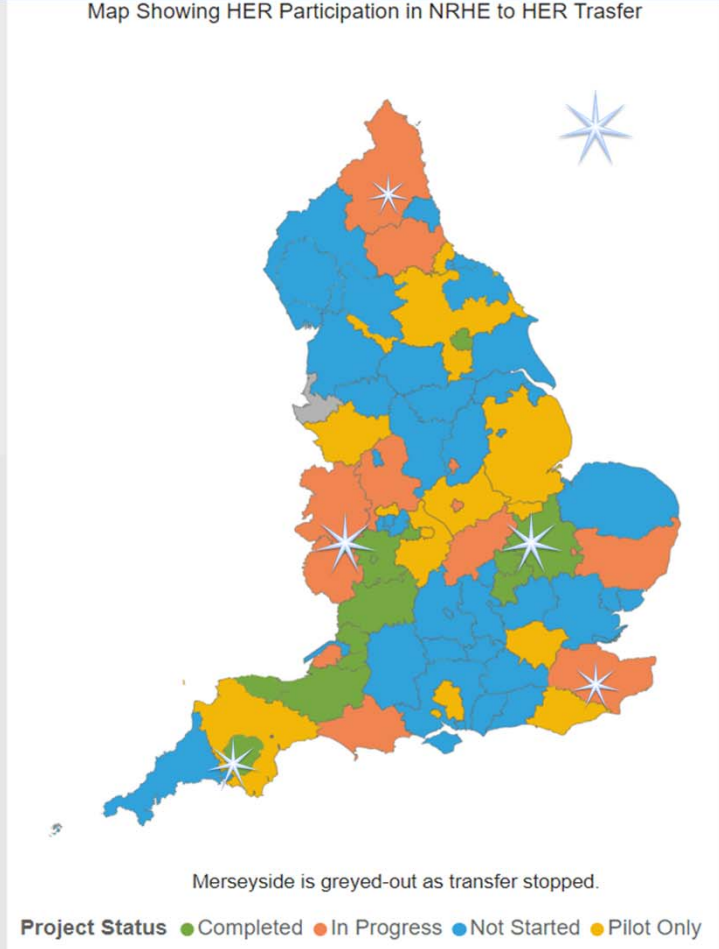
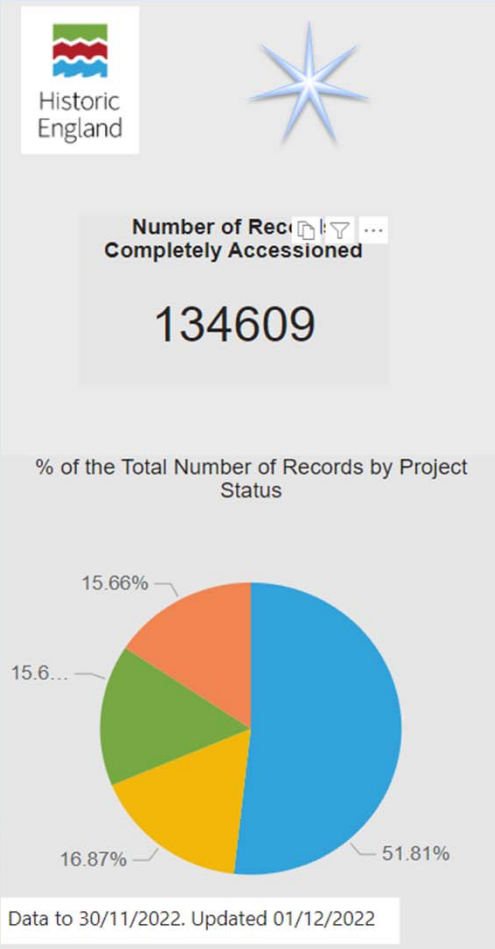

National Security Copy (NSC) of Records (HIAS Principle 7)

- Introduction of **NSC Code of Practise**.
- Template on website
- Needs to be signed by senior management and re-signed every five years
- Senior Managers will receive letters from HE inviting them to sign the code

DMS: secured back-up records locally

Access Protocol: copy of HER record stored with third party in emergency

Code of Practise: details of principles and practices managers must commit to

Heritage Reference Data Manager and National Marine HR

- The interim solution which will allow HE business as usual is still live and an updated version of reference data will be released in January 2023.
- Plans on the enhanced Reference Data Manager project overseen by the Getty Conservation Institute are on the way.
- Issues with the heritagedata.org website. We are investigating solutions for moving the hosting of the linked data to Historic England. Any move will not impact on the
- persistent identifiers.
- HE is currently doing modelling work for the new Mariner database used by the National Marine HR with testing scripts being drafted early next year.

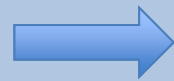
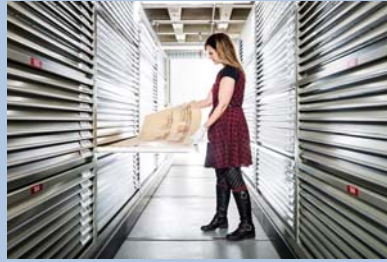
Heritage Gateway Improvement

- Requirements for a core Heritage Gateway record agreed and signed off by the Minimum Units of Information (MUI) workshop
- Following user survey and interviews, first round of user testing have taken place and will inform discovery to scope the website work
- Revision of the HG Content Provision Agreement underway. We are contacting each provider to draw up an onboarding plan (expected to begin early next financial year)
- Initial conversations with data hosts and individual providers around onboarding the new Gateway can be held
