- The QAA is publishing a revised *Code of practice* for research degree programmes
- The research environment is becoming increasingly international, particularly with the formation of the European Research Area

- The UK Government is working with European partners to develop a flexible and responsive higher education system across Europe
- The Bologna Agreement will lead to the harmonisation of higher education degrees across Europe.
