Article submissions

Articles submitted to the journal should be original contributions and should not be under consideration for any other publication at the same time. Authors submitting articles for publication warrant that the work is not an infringement of any existing copyright and will indemnify the publisher against any breach of such warranty. For ease of dissemination and to ensure proper policing of use, papers and contributions become the legal copyright of the publisher unless otherwise agreed.

Submission requirements

Papers should be sent to the Editors, Dr George Cairns and Dr Joanne Roberts, at db.s.cpoib@durham.ac.uk. Papers should be submitted solely by e-mail as MS Word attachments.

All papers will first be considered by the Editors for general relevance and significance. If accepted for review, papers will then be subject to double blind peer review.

Articles should be 5,000-7,000 words in length. Manuscripts should be set out using 12 font with double line spacing and 25mm margins.

A brief autobiographical note which includes full name, affiliation, e-mail address and full international contact details should be supplied for each author. Author details should be supplied on a separate sheet to facilitate the peer review process.

Each article should be accompanied by an abstract of up to 250 words and up to six keywords that encapsulate the principal subjects covered by the paper.

Critical Perspectives on International Business (CPoIB) publishes material that critically engages with the broad field of International Business, including, but not restricted to, issues of globalization, production and consumption, economic change, societal change, politics and power of organizations and governments, environmental impact, etc.

The objectives of the journal are:

- To support single, multi- and trans-disciplinary study
- To encourage reflexive and critical engagement with issues of contemporary interest and relevance in society
- To allow challenge to normative and performative approaches, as represented in managerial textbooks and “mainstream” journals
- To challenge organizational orthodoxy, and governmental and organizational politics and power

CPoIB is the only journal that exclusively supports critically reflexive discussion of the nature and impact of international business activity from trans- and multi-disciplinary perspectives, rather than within specific fields, such as Business Ethics, Economics, etc.

The journal enables academics to engage with, and build upon, writings and activities from the broader societal context that challenge the hegemony of global and transnational corporations, of managerial

orthodoxy, and of dominant academic discourse.

CPoIB supports radical discussion on the nature of globalisation and international business that is academically rigorous, through empirical study and/or philosophical discourse. Moreover, the journal supports and incorporates work that challenges its own “orthodoxy”.

The journal provides a vehicle for the development of the field of Critical Management Studies, where this is concerned with critique of management action and practices, but not with critique as theoretical abstraction.

CPoIB specifically promotes and supports writing that engages in an academically rigorous manner with the “polyphony” of voices of those actors involved in international business – across social and geographic boundaries.
