The Institute of Public International Law and the Netherlands Institute for the Law of the Sea of Utrecht University are co-hosting the Third J.H.W. Verzijl Memorial Symposium on 3 December 2004. The first Verzijl Symposium was held in October 1988 and was entitled "International Arbitration: Past and Prospects" and commemorated the centenary of the birth of Professor Verzijl, who was professor of public international law at Utrecht University. The second Verzijl Symposium was held in 1993 and was concerned with "International Economic Law during Armed Conflict".

The international law of the sea is one of the branches of international law in which professor Verzijl had a particular interest. Among other things, he headed the Netherlands delegation to the first United Nations Conference on the Law of the Sea at Geneva in 1958. The Netherlands Institute for the Law of the Sea, which in 2004 exists 20 years, is a testimony of the continued interest in the law of the sea at Utrecht University.

The adoption of the United Nations Convention on the Law of the Sea in 1982 has led to a period of relative stability in the law of the sea. The Convention offers a sufficient legal framework for the sustainable development of the oceans and its natural resources. However, especially in recent times there have also been calls to amend the Convention because of supposed shortcomings. Renegotiation of the Convention in all probability would be a time consuming process, the outcome of which is highly uncertain. Such a process would almost certainly negatively impact upon international cooperation in the management of ocean space as it is bound to lead to uncertainty and conflict over the applicable legal regime. The Symposium is intended to contribute to the discussion on the significance of the Convention as the basis for the legal order of the oceans. To this end four topics have been selected, which can contribute to an understanding of how the Convention has been adapted to newly arising issues and how further adaptation may be achieved in the future, without a readjustment of the basic legal framework contained in the Convention.

At the Symposium four reports will be presented, each of which will be discussed during one of the four sessions (topics and speakers are included in the program of the Symposium included below). Each of the reports will be analyzed by a commentator before it will be discussed by the Symposium participants. In order to allow an indepth discussion, the papers will be distributed beforehand to the Symposium participants. The reports, comments by the invited speakers and the main interventions during the sessions will be published in the conference proceedings.
