Refugee and Asylum Seeking Women: Challenges, Changes, Choices

Female asylum seekers and refugees have many special needs and the challenges they face are varied and complex. The Refugee Council is one of the leading organisations providing advice and support to these women. This conference aims to highlight some of the issues specific to female refugees and asylum seekers, to develop delegates' understanding of the challenges facing female refugees and asylum seekers, and suggest ways in which mainstream and specialist organisations and agencies can address these issues.

Women experience the types of persecution suffered by men, but they also often undergo forms of abuse specifically linked to their gender. It is sometimes harder for women to have their asylum claims accepted because issues of gender are not explicitly recognised by international refugee law. A lack of gender and cultural sensitivity in service provision can also make accessing essential services problematic or impossible.

The Refugee Council's Women's Strategy leads the way in improving gender-sensitive service provision and policy-making in an effort to overcome many of the obstacles faced by refugee and asylum seeking women in the UK. During the conference, delegates will be invited to consider a range of issues affecting integration and service provision and explore initiatives for improving support for refugee and asylum seeking women in the UK.

Aims and objectives of the conference

- To raise awareness of the barriers to protection facing women seeking asylum and women refugees
- To identify challenges in the areas of asylum and integration such as the application process, accommodation, security, social cohesion, domestic violence, personal safety, education, training and employment, health and legal restrictions
- To demonstrate practical examples in helping to solve and/or deal with these issues and overcome the challenges of gender bias in the UK
- To highlight the public and voluntary sector's work in addressing these issues
- To use the Refugee Council's Women's Strategy to explore issues facing women seeking asylum and women refugees and enable service providers to incorporate ideas for improving service provision and integration in their own work
