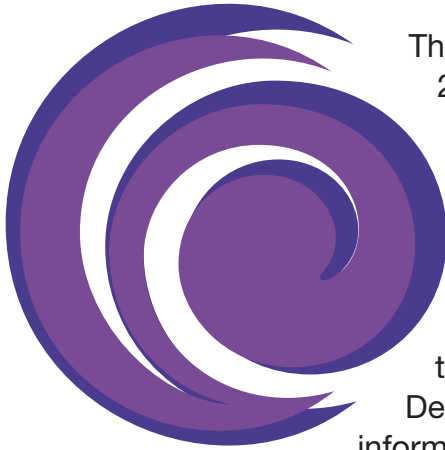

# A call for papers

The SSRG and the Race Equality Foundation are organising a conference in London on Monday 29th January 2007 and are now calling for papers. The overall aim of the conference is to explore research on racism and ethnicity and the messages for policy and practice in key areas of public services, including: housing and health and social care for adults and children.



The 2007 conference will build on previous conferences in 2004 and 2005. The presenters will be asked to identify the policy and practice implications of their research / topic and the conference participants will be invited to identify areas where they can take action in their own work / organisation as a result of attending the conference.

The programme will also include feedback from participants at previous 'Inclusion and Exclusion' conferences on changes in thinking, policy, procedures or practice since the last conference.

Delegates from previous conferences are invited to either submit information on this to the conference planning group or to formally submit it as a separate presentation in response to this call for papers.

Speakers for the plenary sessions will be by invitation. Speakers for the sessions in smaller groups will be selected after this call for papers.

The conference will explore recent findings from quantitative and qualitative research on racism and ethnicity, looking particularly at:

- effective inclusion of black and minority ethnic users in the research process
- ensuring the effective inclusion of equalities issues in all housing and health and social care research
- messages from research for policy and practice
- effective methods for bringing about change and putting research into practice
- using research to tackle institutional racism
- exploring linkages between the experience of discrimination on grounds of race, gender, disability, faith, age, sexuality
- methodological issues in researching racism and ethnicity
- the role of black and minority ethnic researchers in public/voluntary services
- securing funding for inclusive research.

We wish to receive papers that focus on one or more of the above topics. Priorities for all papers will be to address user involvement and the implications of the research for policy makers and practitioners.
