Course Syllabus and Structure

The course commences on 29th and 30th September 2007 with an induction weekend in Leicester, and thereafter the study of the Core Module "**The Sports Regulatory Regime and Sports Rights**" (worth 30 credits). This module is assessed by a combination of coursework and an examination of the Core Module in January 2008. For the remainder of the first year, January to December 2008, students continue with their studies choosing two 30 credit modules or one 30 and two 15 credit modules (giving a total of 90 credits for the first year of study). In the second year, January to December 2009, students take either one 30 credit module or two 15 credit modules and write a 20,000 word project on a topic of their choice on a legal issue within the Sports Law and Practice context if studying for the LLM.

This programme offers the student flexibility and the opportunity to design their own degree programme, and through each year of study the programme seeks to develop as much student choice as possible, enabling the course to be tailor-made for each student. A Negotiated Study Module is one of the module options available, and allows students greater flexibility by enabling them to explore an area of law selected by them and examine its application through detailed critical analysis. Although students will be encouraged to work independently, help and advice can be sought as required.

The course forms part of a wider LLM programme at De Montfort University and for added flexibility, in addition to the Sports Law and Practice modules available, students may choose to study modules from the other LLM pathways - Business Law; Employment Law in Context; Environmental Law; Food Law and Medical Law and Ethics. See Page 5 for some of the modules available from these pathways. To gain a named award in Sports Law and Practice, the Core Module plus one full 30 credit module from the Sports Law and Practice syllabus must be studied. The project must also fall within the scope of Sports Law and Practice. Thereafter there is general freedom of choice across all pathways (subject to some minor restrictions). To gain an LLM in Law, (innominate award) students can choose to pursue any pathway whereby any Core Module is studied followed by a choice of any of the modules on offer plus the compulsory 20,000 word project.

The Project

In year two LLM students write a 20,000 word project on a topic from their chosen area of study. The project is an in-depth study of a specific area of law which provides an opportunity for analysis, leading to a critical review, conclusion or recommendation on an element or elements of relevant law in the UK or elsewhere. The project will be completed under the supervision of a member of the teaching staff for the course.

To graduate with a Master of Laws (LLM) you will need a total of 180 credits. To exit with a Postgraduate Diploma you will need a total of 120 credits.

Questions you may have about the Distance Learning Programme with De Montfort University

What format do the modules take?

The modules come in the form of hard copy print or as PDF documents via the course website. The hard copy modules are bound together and sent out as booklets. If you choose the Negotiated Study module, the content may consist of "free-standing" elements of existing 30 credit modules.

Please note that the Joining Pack and first set of modules are quite bulky, so please ensure that you provide an address where these can be safely delivered.

How will I receive my modules?

The hard copy modules are sent to you by post. For participants worried about the posting times in the country where they will be based, materials can be sent by air courier at an additional nominal charge of £200. Materials sent by air courier will be delivered to your requested module mailing address between 8.30am and 6.00pm Monday to Friday only and will require a signature. The mailing address you provide must be manned during these hours and you must provide a contact telephone number or email address that you can be reached at between 8.30am and 6.00pm Monday to Friday.

Is there any contact time with the course tutors and other course participants?

Students are encouraged to attend a series of Study Days in Leicester throughout the course. The first study weekend is the Induction Weekend on 29th and 30th September 2007. The weekend will give students an opportunity to meet tutors and fellow students, discuss the course and establish access to tutors during the coming year. We do encourage students to get to know other students who will be taking the same modules. Four further Study Days are planned per year of study and these will take place in March, May and November and will give you the opportunity to listen to and be involved in specialist debate and analysis on specific areas of relevant law.

How will my work be assessed?

Following the examination of the core module in January of your first year, final assessment of 15 and 30 credit modules and the project are based on the submission of assignments. All of the modules contain clear instructions about written work. 30 credit modules have three compulsory assignments. The first two assignments are 3,000 words long while the third is an integrative piece drawing together items from the whole course and is 6,000 words long. 15 credit modules have two compulsory assignments each of 3,000 words in length. In both cases you can choose to submit one item in draft for comment before making a final submission.

How long will I spend studying each module?

People study at different rates, but the course is based on a total of 150 hours per 15 credit module, including time spent on assignments.

How will I access the relevant reading materials?

It is important to realise that the materials provided are not self-contained but point towards the books, articles, cases, statutes and reports which you will need to read. Online links are provided via the University's course website to various on-line legal resources which De Montfort University subscribe to, such as Butterworths Direct and Westlaw. It is, nonetheless, important to have access to a good law library. Some university libraries are reluctant to allow external readers to borrow so it may involve time spent reading in libraries or the expense of photocopying the necessary material. De Montfort University Library provides a photocopying service for which a charge is made. The De Montfort University Law Librarian is available to help throughout the course and will be present at the Induction Weekend to explain the use of the library facilities and to advise you on suitable libraries near your home.

How do I enrol for the course?

Do I need to have a Law Degree?

No. The standard entry requirements for the course are either a degree in law or another discipline from a UK university or a relevant professional qualification or an equivalent international qualification which indicates an ability to study at the postgraduate level. Whilst some background knowledge of law is useful, a degree in law is not essential.

The course fees for students enrolling in September 2007 are £3,000 (VAT exempt) per year of study. Fees include the provision of all course materials, tuition costs, access to relevant on-line legal resources at De Montfort University such as Butterworths Direct and Westlaw, the Induction Weekend and four further Study Days. Please note that travel and accommodation costs are not included in the fees and must be covered by the student.
