What you need to know

Entry requirements:

Five GCSEs at grade C or above including Mathematics and English Language.

Entry onto this course is based on:

CILIP certification [ACLIP]

A personal portfolio which demonstrates a mixture of formal national qualifications and CPD qualifications such as CILIP and ASLIB training courses.

English language requirements:

International students are required to satisfy a minimum requirement regarding their proficiency in both written and spoken English. This requirement is currently a British Council International English Language Testing Systems (IELTS) score of 6 (or above) or a Test of English as a Foreign Language (TOEFL) score of 575 (or above)

What are the career benefits for doing this programme?

This distance learning course is aimed specifically at those working at a paraprofessional level within the library and information sector and who wish to gain a recognised professional qualification.

What are the transferable skills/knowledge from this programme?

Although this Work Based Learning programme is specifically designed to meet the needs of the Library and Information Services sector, many of the topics covered have relevance across many other sectors such as; research, information retrieval and organisation, web management and independent project management.

Programme Structure

Year 1:

Management for Information Professionals

This module is designed to explore managerial concepts which enable information functions or organisations to set and achieve their aims and objectives.

Information Organisation and Retrieval

This module explores the theory and practice surrounding information, its organisation and retrieval.

Cataloguing and Classification

This module will develop your knowledge of theory and current practice in descriptive cataloguing and classification, and the industry standards, practice and issues that are relevant.

Collection Management

The overall aim of this module is to study the management and organisation of the collections within a range of information environments.

Legal and Ethical Context of Information

This module explores the concept of the information society and examines this further in the context of related legal and ethical systems.

Work-based project 1

The focus of the module is to enable you to apply the principles and theories of library and information management to an aspect of your work place, within the context of good practice in the sector

Year 2:

Web Publishing & Management

In this module you will study advanced principles of Web page development and learn some techniques that can make a Web site more interactive.

User needs analysis and learner support

Learning support is a process whereby endusers of information products and services are helped to become efficient and effective independent information users.

Research Methods for Evidence Based Practice

This module will cover the principles of research methodologies, concentrating on qualitative and quantitative approaches.

Work-based project 2

This module will enable you to carry out research into an aspect off service in your organisation, with the support of an academic supervisor.

What qualifications can you achieve?

Students receive an internationally recognised Bachelor of Science degree award.

Accreditation and career opportunities

This course will be accredited by CILIP and as such is recognised as a professional qualification.

How will you be assessed?

Assessment is varied, and is determined by individual module tutors. However it can consist of a variety of coursework assignments. Assignments can take the form of individual and/or group work, research reports, portfolios of exercises, evaluations and essays. Some modules may have elements of practical work that require the use of computer systems.

Student Support

All students have access to a virtual learning environment where learning resources are available, including the opportunity to participate in online discussion groups. The University offers a range of support services for Distance Learning students.

Student scholarships for international students

A limited number of scholarships may be awarded for the programme. Applications for scholarship are considered on an individual basis and any award is primarily determined by consideration of academic achievement.
