RESEARCH SEMINAR SERIES: PLANNING AND SUSTAINABILITY

In the last two decades, the concept of sustainable development has emerged as a new policy orthodoxy in the fields of urban development and planning. The sustainability agenda promises the delivery of new forms of economic development that can be balanced with social justice and environmental sustainability. However, despite its appeal to policy-makers and businesses, the term has been increasingly problematised by academics and critics. In fact, the deliberate haziness of this term has left space for its continuous re-definition by different groups and with different aims, with the result that sustainability seems to have meaning only when it is adapted and recontextualised in different local, regional and national environments. Sustainability can act as a label that can be attached to any policy proposal to enhance its legitimation and attractiveness. This is particularly evident in the UK, where the Sustainable Community Plan (1997) has been directly related to broader conceptions of mix, diversity and spatial balance.

These research seminars aim to reflect different aspects of the relationship between planning and sustainability, providing a contribution to enlarging and enriching the debate around it. Academics from different universities and departments have been invited to share and discuss findings drawn from their recent research.
