# **KEYNOTE** SPEAKERS

**Christine Breakey** has over 25 years experience of working with people on the Autistic Spectrum in a variety of settings, including social work, homelessness and education. She now manages Spectrum First which she set up in response to the dissatisfaction which autistic people expressed with their service provision.

Christine has particular expertise in supporting students in Further and Higher Education and is a respected trainer in this field. She also provides Asperger specific CBT counselling and advocacy and acts as an expert witness to the courts. Christine is co-author of *Access and Inclusion for Children with Autism Spectrum Disorders* and author of *The Autism Spectrum and Further Education*. She is currently writing an autobiographical book, due to be published in 2009 entitled *Life with an Aspie Mother*. Christine is committed to challenging inequality and discrimination at all levels and uses inclusive and person centred practice.

**Dan Goodley** is Professor of Psychology at Manchester Metropolitan University. His research engages with the areas of disability studies, learning disabilities, narrative research and critical community psychologies. Dan believes his research brings together three key areas - (1) Disability, diversity and social change, (2) Innovations in qualitative research, (3) Deconstructing professional and institutional practices. He tries to promote dialogues with a whole host of professions and professional practices in various educational, health and social welfare positions. Embracing critical theoretical resources from disability studies and psychology, offers possibilities for potentially liberating talk, critique and evaluation with teachers, disability service workers, nurses, social workers, voluntary worker and carers.

**Luke Beardon** is a senior lecturer in Autism at Sheffield Hallam University. Luke has been working for several years in the field of Autism and Learning Disabilities, in capacities ranging from researcher to trainer. He started work for the National Autistic Society (NAS) as a Service Co-ordinator assisting in the development of a residential service supporting young adults with a range of complex needs, from those with high dependency needs and severe learning disability, to individuals with a diagnosis of Asperger Syndrome.

Luke works closely with the community, supporting families and individuals with Autism and Asperger Syndrome, acting as a non-clinical consultant on a wide range of issues. Luke co-wrote the ASPECT consultancy report, the largest consultation with adults with Autistic Spectrum undertaken at the time; and is co-editor of two books on Asperger Syndrome published by Jessica Kingsley.

During the afternoon session there will be the opportunity for delegates to elect to join with a group facilitator to explore a particular theme of the conference in a small experiential group.
