





4 postdoctoral positions to be filled for research fellows in

Philosophy, Psychiatry and Neuroscience

The Institute of Cognitive Science (**IKW**) at the University of Osnabrück, Germany, and the Faculty of Medicine of Bonn University (**UKB**), Germany, seek applicants for four postdoctoral positions to work up to three years in the interdisciplinary research project *animal emotionale II – Existential Feelings, Psychopathology and the Range of Evolutionary Explanations* funded by the VolkswagenStiftung (the positions allow for further scientific qualification, e.g. Habilitation).

The research fellows will pursue intimately interwoven philosophical questions and neuroimaging studies with healthy subjects and patients in order to investigate basic emotions and existential feelings. The research projects will start October 1, 2009. The successful applicants will be chosen during a joint symposium on June 29.

Postdoctoral position at the IKW

(Salary level EG 13 TV-L)

The aim of the project is to provide a comprehensive and systematic philosophical analysis of existential feelings. The successful applicant will cooperate closely with the research fellows in psychiatry and neuroscience at the UKB.

Applicants should have an excellent PhD degree in philosophy or a related discipline that includes a substantial philosophical component. In addition, applicants should have expertise in philosophy of emotions or affective science, and they should have experience in interdisciplinary research.

Postdoctoral position at the IKW

(Salary level EG 13 TV-L)

The successful applicant will be concerned with the philosophical problems (in particular from the point of view of the philosophy of science) that arise with regard to the testability and explanatory power of evolutionary explanations, in particular explanations of the basic emotions fear and disgust. She/he will cooperate closely with the research fellows in psychiatry and neuroscience at the UKB.

Applicants should have an excellent PhD degree in philosophy or a related discipline that includes a substantial philosophical component. In addition, applicants should have expertise in philosophy of science (with a stress on evolutionary theory or philosophy of biology), and they should have experience in interdisciplinary research.

Postdoctoral position at UKB

(Salary level EG 14 TV-L)

The successful applicant will work on the psychopathology and neurophilosophy of fear, disgust and existential feelings, and conduct an fMRT study on patients with derealization- or depersonalization-syndrome. She/he will cooperate closely with the research fellows in philosophy at the IKW.

Applicants should have completed their medical doctor excellently, have considerable clinical experience in psychiatry and psychotherapy and have substantial knowledge in psychopathology. In addition, applicants should have experience in interdisciplinary research.

Postdoctoral position at UKB

(Salary level EG 13 TV-L)

The successful applicant will pursue neuroimaging studies related to the primary experience of fear and disgust and will be concerned with the empirical investigation of existential feelings. She/he will cooperate closely with the research fellows in philosophy at the IKW.

Applicants should have an excellent PhD degree in psychology or cognitive science or completed their medical doctor, and they should be familiar with the analysis and interpretation of neuroimaging data. In addition, applicants should have experience in interdisciplinary research.
