It covers seven domains: health, subjective well-being, personal relationships, material resources, education, behaviour and risks, housing and the environment. Comparisons are made of countries performance on each of the domains and components

RIDLER, C. ET AL. National Child Measurement Programme: detailed nalysis of the 2007/08 National Dataset. Oxford: National Obesity Observatory, 2009 ISBN: Number of pages: 33pp

The National Child Measurement Programme (NCMP) weighs and measures the height of children in Reception (typically aged 4-5 years) and Year 6 (aged 10-11 years). The findings are used to inform local planning and delivery of services for children and gather population-level surveillance data to allow analysis of trends in excess weight. The programme also seeks to raise awareness of the importance of healthy weight in children. The NCMP is part of the government's strategy to tackle the continuing rise in excess weight across the population. This report analyses the NCMP 2007/08 national dataset provided by the NHS Information Centre for Health and Social Care (NHS IC). The NHS IC collates and analyses NCMP data centrally after they have been collected at a local level and submitted by Primary Care Trusts (PCTs), with the support and cooperation of schools, children and parents. The UK has one of the most liberal drug policies in Europe. Both Sweden and the Netherlands (despite popular misconceptions) have a more rigorous approach.
