## **PURPOSE OF THE CONFERENCE**

Following the 2009 reorganization of the Government, for the first time in living memory there is no longer a Ministry with either the word 'Education' or 'Universities' in its title. Now that higher education is embedded within the Department for Business, Innovation and Skills, it remains to be seen whether this sector will get a better deal from the Government. Clearly there are both risks and opportunities to be grasped through the linking of universities with business, and this structure should mitigate the risk of one becoming too detached from the other.

Perhaps this can be seen as a natural continuation of the policy of the Government and HEFCE over the last two years; there has been a major initiative aimed at attempting to find and fund ways for the HE sector to respond more effectively to the needs of employers. This has led to different institutional models and approaches to effective employer engagement.

Unfortunately, this initiative is playing out against a background economic situation dominated by the financial crisis, and a reduction in the overall number of graduate vacancies. There has been a surge in applications for a university place, partly due to demographics, but also with a big increase in applications from mature students, with the more vocational courses seeing the biggest increases. This large rise in applicants has happened at a time of a spending squeeze, and a result seems to be that the Government is wishing for the HE sector to take more students without a commensurate increase in funding.

On the other hand, potential developments such as 'no fee degrees' may help to promote wider access to HE, and other published contributions to the late-2008 'Higher Education Debate' such as calls to encourage parttime study and transfer of students between institutions, the linking of fees to modules rather than to programmes, and the augmenting of the current degree classification with a better description of what the student has actually achieved may well lead to interesting developments in the coming year.

Finally, the Government will be reviewing the role and effectiveness of quangos, which may have an impact on the future of funding in the HE sector.

In the light of these developments, and with such a rapidly moving picture, we are fortunate to have two keynote speakers who are at the heart of policy-making and governance in the sector. Dr John Selby, HEFCE's Director for Education and Participation, will address HEFCE's view of the recession and credit transfer, considering the current state of credit frameworks and credit transfer, and the implications of the recession for learners, institutions and the HE funding system.

Anthony McClaran, the CEO of UCAS between 2003 and 2009 will reflect on the lessons learned during the five years in this role, and the light it may shed on issues of student engagement in the work of the QAA. Anthony will take up his role as CEO of QAA in October, and his talk will be entitled, "From applicant service to student engagement: an applicant-centred perspective on the work of QAA".

#### **ISSUES FOR WORKSHOPS**

Speed dating with Bologna

Workshop Leader: Professor Tim Birtwistle, Professor of the Law and Policy of Higher Education, Leeds Metropolitan University, UK Bologna Expert

This session will encompass the origins of the Bologna Process, and the general scope of the action lines. The position of the United Kingdom within the overall framework will be considered. The potential effects of the 2009 Leuven Communiqué, issued at the end of the Conference of European Ministers Responsible for Higher Education, will be explored, alongside the Universities UK response to "2010 and beyond". The opportunity to discuss such a range of issues will be timely as 2010 was set at the start of the Bologna Process as the deadline for the creation of the European Higher Education Area.

# B What is the QCF and how will it benefit learners?

Workshop Leader: Elizabeth Vidis, Policy and Delivery Manager in the Adult Skills team at the Qualifications and Curriculum Authority (QCA)

At present, it is hard to understand all the different types of qualifications that learners hold – what level they are, how long they take to complete, what content they cover, and how they compare to other qualifications. The new Qualifications and Credit Framework (QCF) will help present qualifications in a way that is easy to understand and measure, and is at the heart of reform in the vocational qualifications system. The QCA hopes that the qualifications offered will be "far more relevant to the needs of employers and more flexible and accessible for learners". Discussion may explore ways in which learners can carry credit between the vocational and the HE frameworks.

# Higher level skills for business

Workshop Leaders: Lindsey Bowes, Head of Skills and Innovation (HE), CFE Consultancy; Tristram Hughes, Project Manager, CFE Consultancy

In 2006, Leitch threw down the gauntlet to policy makers and providers to enhance the UK's higher level skills base through increased workforce development and employer engagement in higher education (HE). It was within this context that CFE embarked on an extensive programme of research to establish the appetite for higher level skills amongst employers. The research explored the extent and nature of demand for training at higher levels, including employers' perceptions and experiences of flexible models of programme delivery being developed by HE providers, such as credit accumulation and transfer (CAT), accreditation of in-house training and the accreditation of prior and experiential learning (APEL).

This workshop will consider employers' perceptions of the strengths and weaknesses of flexible approaches to higher level skills training delivery and evidence that has been collected on the potential impact of the recession on take-up of training at higher levels. We will finally offer some key messages for HE providers seeking to engage more effectively with employers.

# Outcomes-based education: new pathways to qualifications

Workshop Leader: Morag Harvey, senior project officer in the Centre of Outcomes-Based Education, Open University

The Centre of Outcomes-Based Education (COBE) is a research and development unit supporting innovative curriculum design. The Centre works with academic and non-academic units, and with central and regional staff, to support and implement priority curriculum developments. Current research encompasses the Recognising Achievement Project (RAP), jointly run by COBE and the OU's Credit Transfer Centre. This is a two year project to develop new pathways to qualifications via negotiated learning and accreditation of experiential learning. The workshop will explore the work of COBE in relation to Learning Outcomes and the way these have been used to develop different curriculum initiatives at the OU. This will be followed by workshop discussions.

## **MORE ABOUT NUCCAT**

The Northern Universities Consortium for Credit Accumulation and Transfer is a federation of 44 Higher Education (HE) institutions and HE related bodies in northern and central England and Northern Ireland. The membership includes the Universities and Colleges Admissions Service (UCAS), the Open University and some regional university associations. Working through its membership and in collaboration with other credit bodies, NUCCAT seeks to

- share best practice in the development of modularity, credit frameworks and academic frameworks, including assessment
- promote staff development in these areas
- · work with other consortia to resolve issues of common interest
- · undertake specific projects on credit

The consortium holds quarterly meetings in September, December, March and June each year. It organises an annual conference in the autumn and has established an annual series of regional workshops to assist member institutions with staff development.

NUCCAT meets regularly with representatives of the other F/HE credit bodies through the United Kingdom Credit Forum.
