## On the agenda

#### 1. The Operating Framework

The Operating Framework for the NHS in England for 2010/11 has been published and, for the third year in a row, the national priorities for the NHS remain consistent but regional variation in performance must be tackled. This will provide important stability in helping the NHS achieve the vision set out in NHS 2010-15: from good to great. Preventative, people-centred, productive, launched last week.

2010/11 is a pivotal year. The NHS still has significant growth in that year, averaging 5.5 percent. As such, in 2010/11 growth must be used to put into effect the changes that will deliver the most benefits to patients in the future. The Operating Framework provides a set of enablers and tools for the NHS to drive the transformation that will be required.

#### 2. Sir Liam Donaldson to step down

It was announced this week that England's Chief Medical Officer, Sir Liam Donaldson, will step down in May 2010 after 12 years of service.

Sir Liam is the 15th person to take up the independent role since the first Chief Medical Officer was appointed in 1855, as a response to the cholera epidemics that swept Victorian England. Since 1998, Sir Liam has been at the forefront of reforms to the NHS and major improvements to the country's public health. Andy Burnham said: 'Sir Liam has fulfilled his duties in this important public office with great distinction, wisdom and good humour. He has brought courage and foresight to the role of improving the nation's health.'

#### 3. Swine flu

The number of cases of swine flu has continued to decrease, with an estimated 9,000 new cases in the week ending 13 December. The number of people in hospital with swine flu has also decreased.

Professor David Salisbury, Director of Immunisation, has written to all medical directors and regional directors of public health to update them on the change in dosage for children receiving the Pandemrix vaccine.
