# **Types of Presentations**

- Individual paper or presentation: 35 minutes including at least 10 minutes for discussion
- Panel presentation: three 20-minute presentations with 15 minutes for discussion
- Workshop: 75 minutes allowing at least 30 minutes for non-presenter participation
- Round-table discussion: 75 minutes including non-presenter participation
- Poster presentation

## The language of the conference

Although the conference will take place in Israel where Hebrew and Arabic are the official languages, we will follow the procedure of other European international academic writing conferences such as EATAW. The conference language will be English, today's international language. All keynote presentations and other plenary events will be held in English. Participants are expected to have sufficient competence in English to participate receptively in all conference events. However, since English is not the working language of many of IFAW's members, we would like to invite contributions in Hebrew, Arabic, and other languages provided there is enough of an audience to warrant such a contribution, and that the following guidelines, suggested originally in the call for papers of the 2009 EATAW conference, are followed:

- a) An abstract/proposal must be submitted in both English and the language of the presentation.
- b) During the session, visuals such as PowerPoint should include subtitles or a summary in English.
- c) If there are handouts, a handout in English should also be provided.
- d) The person chairing the session should be prepared to propose solutions for multi-language situations. Although there will be no official interpreting service, bilinguals may offer ad-hoc interpreting to those who need language assistance.
- e) The presenter may submit the final paper for publication in the proceedings in the language of the presentation, but an English abstract must be provided.

Contributors should bear in mind that participants from other parts of the world may not be familiar with their educational systems, national organizations, terminologies and abbreviations. Please be explicit with regard to all cultural assumptions your presentation may contain. While English is the lingua franca of the conference, many IFAW members teach writing in their own language and many do not have native-speaker proficiency in English. We ask you to bear this in mind when preparing and giving your contribution.

#### **Abstracts for all proposals** should consist of a maximum of 300 words and include

- Title
- Language of presentation
- Type of presentation and participant interaction (e.g., workshop, paper, demonstration of classroom practice/method or technological program)
- The issues/approaches/skills to be explored
- Theoretical framework (Demonstration sessions may not need a theoretical discussion as long as they have direct implications for classroom instruction or research.)

**Body of email:** Please include title of presentation, name of presenter(s), institutional affiliation(s), contact information, and country in the email message. Do *not* include presenter information in the word document.

#### **Selection of Abstracts for Presentation**

Abstracts will be evaluated blindly, based on the following criteria:

- Is the topic relevant to the conference theme?
- Is the approach to the topic original?
- Are the issues presented appropriate for the conference participants?
- Is the presentation placed within a theoretical framework?
- Is the issue that prompted this presentation clearly stated?
- Are the implications for pedagogy or research clearly stated?
