1. Care Quality Commission

All 378 NHS trusts providing services in England are now registered with the Care Quality Commission (CQC), whose full legal powers come into force today.

By law, trusts must be registered with the CQC to provide care. To be registered, trusts needed to show that they meet new essential standards of quality and safety, which the CQC will constantly monitor. Detailed information is available on the COC website:

2. Building the National Care Service

Health Secretary Andy Burnham launched the White Paper, Building the National Care Service, earlier this week. The publication sets out plans to radically reform care and support across England over the next few years, making the system fair and affordable for all, and guaranteeing services that are free to eligible people when they need them.

The White Paper builds on the biggest ever consultation on care and support, with around 70,000 responses from the public, carers and through representative organisations.

3. Swine flu update
