The Role

The KTP Associate will be based at the Research & Development laboratories of

Pfizer UK Ltd, Sandwich, Kent and will have specific responsibility for working on a Knowledge Transfer Partnership (KTP) project between the University of Kent (School of Anthropology and Conservation and School of Psychology) and Pfizer. The project will utilise a social science approach toward understanding workplace culture.

The KTP Associate will report to Dr. Daniela Peluso at the School of Anthropology and Conservation, Dr. Joachim Stoeber at the School of Psychology and the Winning Attitude Team at Pfizer, Ltd., Sandwich. The Associate will be responsible for researching Pfizer's workplace environment(s) while simultaneously developing their internal anthropological capacity toward understanding their own workplace culture(s) and designing appropriate interventions.

Working with the Senior Leadership Team at Pfizer, the KTP Associate will have the unique opportunity to have ethnographic access to the largest global pharmaceutical company at the largest research and development site in Europe. Despite significant contributions by anthropologists and social scientists toward understanding and addressing the complexities of organizational life, there is still only a scant academic anthropological literature that has resulted from these endeavours, even less with regard to the pharmaceutical industry. By examining such an environment through a KTP, the Associate will be in a unique position to broaden an institutional business model to support anthropological models that view 'culture' as ongoing, fluid and non-static. It is therefore, particularly exciting to have the opportunity to engage in a KTP project that will enable such an endeavour at Pfizer.

The KTP Associate will be supervised in the use of ethnographic methods and tools from anthropology and social psychology to address four main questions:

- 1) What are current workplace beliefs, discourse(s), values and practices in a pharmaceutical industrial setting?
- 2) What are the relationships between current workplace culture(s) and issues of leadership, loyalty, commitment, motivation, efficiency and the 'employee experience'?
- 3) What are the gaps between the current and desired workplace culture(s) at Pfizer?
- 4) What key changes can be initiated toward achieving a positive workplace environment?

These questions will be examined through academically focused and on-site activity and research, and through working in collaboration with key divisions at the Pfizer Sandwich Research Laboratories.

Key Accountabilities / Primary Responsibilities

- The KTP Associate will develop an understanding of the different areas of Pfizer business (e.g. research, drug safety, clinical development) and their interactions including the impact on workplace culture
- The Associate will analyse the social relations surrounding commercial products as they move through various phases of the pipeline

 The Associate will interact with the highest levels of leadership at the Pfizer Sandwich site and gain insights into company-wide management and leadership

 The KTP Associate will be encouraged to be methodologically innovative, and will be expected to work collaboratively across disciplines with both the Academic and Pfizer leadership teams.

Key Duties

- The Associate will design, initiate and gauge interventions and deliverables aimed toward positive culture change
- The Associate will design feedback processes to foster senior leaders awareness of existing company culture and its impact as an intangible corporate asset.
- The Associate will disseminate findings from this project both internally through reports/presentations/multi-media via Pfizer internal networks and also externally via collaborative publications in peer reviewed journals.
- The Associate should have the ability to take responsibility for all aspects of the KTP project, to work as part of a team, meet deadlines and to work on a range of different project aims concurrently
- The Associate will carry out a qualitative/quantitative assessments of Pfizer employees' workplace perceptions/experiences
- The Associate will be willing to train individuals at Pfizer in appropriate qualitative and quantitative methods
