

# **Call for Papers / Exhibits**

# Lab4Living at Sheffield Hallam University is pleased to announce the Call for Papers for the first European Design 4 Health conference 2011. The conference will be held at Sheffield Hallam University from 13 - 15 July 2011, Sheffield, UK.

This conference seeks to explore the relationship between design, and health and wellbeing. Good design can deliver widespread benefits to society but how can design practice and processes meet the challenges of health and wellbeing in the 21<sup>st</sup> Century? Through this conference we aim to develop environments and propose creative strategies for future living in which people of all ages and abilities 'not merely survive' but are enabled and empowered to live with dignity, independence and fulfilment.

The conference provides a platform for dialogue between designers, healthcare professionals, funding bodies, researchers and users.

Keynote speakers include Roger Coleman, Geraldine Fitzpatrick and Miles Ayling. The conference features an exhibition of innovative health related artefacts and designs plus special sessions and workshops.

Those participating in the Call for Papers and Exhibition Proposals might include designers, practitioners and researchers in health and wellbeing, and representatives from the health and design industries and funding bodies.

Conference themes are described below. Authors may submit in **either or both** of the following categories:

#### **Call for Papers**

We invite submissions for presentations that address the conference themes below. Papers are invited in the form of a written abstract. This will be independently reviewed and, where appropriate, commented upon. Successful authors will be invited to present their work at the conference.

The language of the conference is English and all submissions should be in English. Submissions should be a maximum of 300 words. Up to 5 images may also be included.

Your abstract should describe the context of the research, questions addressed, how the research has been developed including research methods, findings or conclusions, and be supported by references.

References should use the APA reference style (6<sup>th</sup> edition).

Abstracts will be double blind reviewed; **please do not include your name or affiliation.** All abstracts will be independently peer-reviewed by at least two members of the European Conference on Design for Health 2011 review committee.

Prizes will be awarded for the best paper presentation.

# **Call for Exhibition Proposals**

A peer reviewed exhibition will be held as part of the conference. We invite individuals, organisations and industry to submit exhibits of innovative artefacts or systems that they believe make significant progress in design for health. We particularly invite new products that are considered to be exemplars in their field for good design.

All submissions will be independently peer-reviewed by members of the European Conference on Design for Health 2011 review committee. Prizes will be awarded for the best exhibit.

#### Submitting your exhibition proposal

Please submit a portfolio or sketches (in PDF format) and a 100 word abstract describing the design and the rationale behind its creation. The abstract should also contain details of what you intend to exhibit (e.g. poster, artefact etc).

At the submission point, you will be asked to provide details of any specific requirements you will need for your exhibit e.g. equipment, technical support, security measures, estimated value (if over £3000) for insurance purposes. If you would like more information about the exhibition space, or an informal chat about submitting an artefact, please feel free to contact us before making your submission.
