



- Use internet-based sources of medical information and searchable databases to obtain and apply valid, relevant, state-of-the-art information at the point of care;
- Identify barriers and solutions to implementing evidence-based care in their own practices.

Special Workshop on Teaching and Leading Evidence-Based Practice

Goal: To provide teachers of health care professionals with instruction and practice in teaching information mastery. Instructional materials will be provided for use at the learner's home institution.

Educational Objectives—At the conclusion of this course, learners should be able to:

- Describe common problems and solutions associated with teaching information mastery concepts and techniques;
- Identify teaching opportunities in a clinical environment, including inpatient and ambulatory practice settings;
- Explain and apply multiple approaches to teaching information mastery, such as through modifications of the traditional Journal Club format.
