As part of its mission to become a leading centre for policy research and teaching in the region, the Department invites applications for a full-time position in Public Administration, Public Management or Public Policy. Candidates with expertise in the following areas are particularly encouraged to apply: public sector financial management, policy analysis, performance measurement and evaluation, social policy, business-government relations, regulation and regulatory analysis.

Applicants should have a doctoral degree in Public Policy, Political Science, Public Administration or a related discipline, an established record of research, teaching experience, and the ability to engage with policy and research communities in Asia and around the world.
