## **Department of Geography & Sustainable Development**

The School of Geography & Geoscience is the top-rated Geography Department in Scotland, performing well in the last Research Assessment Exercise. The School has several strategic the Centre for Housing Research (http://www.stresearch groups including andrews.ac.uk/chr; the ESRC-funded Longitudinal Studies Centre – Scotland (www.lscs.ac.uk); the Centre for Geoinformatics (http://www.st-andrews.ac.uk/geoinformatics/), the ESRC-funded Administrative Data Liaison Service (www.adls.ac.uk) and the ESRC Centre for Population Change (CPC) (http://www.cpc.ac.uk) - a collaborative initiative involving researchers at the University of Southampton and a consortium of Scottish Universities led by St Andrews.

A key dimension of the advertised post is to provide leadership to the **Centre for Housing Research** at the University of St Andrews. Founded in 1990, the Centre has built on its strengths to become the largest housing research centre in Scotland and one of the leading centres in the UK. In the last 12 years the Centre has attracted funding in excess of £10million from Government, charitable trusts and RCUK grant funders. The Centre is looking to build on this success as a provider of international, world-leading and policy relevant research. The new Director will have the opportunity to continue the development of the Centre, building upon existing expertise in recording and analysing administrative data, researching housing systems and assessing the impact of housing outcomes on individuals, the economy and wider environment. The Centre has recently established the *Scottish Cities Knowledge Centre* and has an ambitious research agenda embracing intergenerational justice, community resilience, scales of governance and understanding the implications of migration and diversity for housing outcomes and life-course patterns.

This is an exciting opportunity to champion new initiatives in the **Centre for Housing Research** at a key phase in its development. These new initiatives will build on existing world class research programmes already located within the Centre, School and University.

## The University & Town

Founded in the early 15th century, St Andrews is Scotland's first university and the third oldest in the English speaking world.

Situated on the east coast of Scotland and framed by countryside, beaches and cliffs, the town of St Andrews was once the centre of the nation's political and religious life.

Today it is known around the world as the 'Home of Golf' and a vibrant academic town with a distinctively cosmopolitan feel where students and university staff account for more than 30% of the local population.

The University of St Andrews is a diverse and international community of over 9000, comprising students and staff of over 100 nationalities. It has 7500 students, 6000 of them undergraduates, and employs approximately 1840 staff - made up of c.700 academic and c.1140 support personnel.

St Andrews has approximately 50,000 living graduates, among them Scottish First Minister Alex Salmond and the novelist Fay Weldon. In the last 90 years, the University has conferred around 1000 honorary degrees; notable recipients include Bob Dylan, Benjamin Franklin, The Dalai Lama, Dame Judi Dench and Jack Nicklaus.

The University is one of Europe's most research intensive seats of learning. It is the top rated University in Scotland for teaching quality and student satisfaction and among the top rated in the UK for research. The 2008 Research Assessment Exercise judged 94% of the University's research activity as internationally recognised with over 60% world leading or internationally excellent.

St Andrews is consistently held to be one of the United Kingdom's top ten universities in university league tables compiled by The Times, The Sunday Times, The Guardian and The Independent Complete University Guide. It has five times been named the top multi-faculty university in the UK in the National Student Survey. The 2011 Times Higher Education World Rankings places the University in the top 100 overall, in the top 25 for Arts and Humanities and in the top 20 for international outlook.

Its international reputation for delivering high quality teaching and research and student satisfaction make it one of the most sought after destinations for prospective students from the UK, Europe and overseas. In 2010 the University received on average 11 applications per place. St Andrews has highly challenging academic entry requirements to attract only the most academically potent students in the Arts, Sciences, Medicine and Divinity.

The University is closely integrated with the town. The Main Library, many academic Schools and Service Units are located centrally, while the growth in research-active sciences and medicine has been accommodated at the North Haugh on the western edge of St Andrews.

As part of its 600<sup>th</sup> anniversary celebrations, launched by graduate Prince William in 2011 and running to 2013, the University is pursuing a varied programme of capital investment, including the refurbishment of its Main Library and a major investment in its collections, a new biomolecular research facility, the refurbishment of the Students' Union and the development of a wind-farm to offset energy costs.

The School of Geography & Geosciences occupies the Irvine Building, which is located in the historic town centre near the University Library and overlooks St Andrews Bay. The Centre for Housing Research, with its significant staff component, is located in its own building, in a semi-rural setting, some 20 minutes walk from the School The working environments of both the School and the Centre are informal, friendly and relaxed. Social events organised by student societies also promote good relationships between staff and students.
