

# Grad Cert/BSc (Hons) **Workplace Health Management**

This programme enhances understanding of the effects of work on health and health on work. The role of the occupational health practitioner is explored in relation to health and risk assessment, including compliance with the requirements of health and safety and employment legislation. The potential environmental impact of work processes is incorporated within the BSc programme.

This course is designed for practitioners who wish to develop their knowledge of workplace health management in a diverse range of settings. It is attractive to a variety of health care practitioners including occupational therapists, physiotherapists and nurses who have qualified overseas but are not currently registered with the Nursing & Midwifery Council (NMC).

All assessments are workplace focused: the requirements of employment and health and safety legislation are key components. The course can be studied on a full-time or part-time basis and standalone units are also available.

- Applicants must have access to an occupational health practice area to fulfill the practice requirements of the programme
- Applications are welcome from practitioners who have qualified and practiced overseas, who may not be registered in the UK.
