Cancellations: You may cancel any booking by giving us notice in writing.

If you cancel within 7 working days of submitting your booking, you will receive a full refund of any monies paid in advance.

If you cancel after 7 working days of submitting your booking, you will incur a £30 administration charge and a cancellation fee will be charged based upon the date of notification as follows:

Our cancellation rights:
