OXFORD BIBLIOGRAPHIES GRADUATE STUDENT AWARD

The **Oxford Bibliographies Graduate Student Article Award** is an invitation-only annual award that offers experienced doctoral candidates an opportunity to contribute to *Oxford Bibliographies*. This competition offers graduate students a unique chance to draw attention to their work and to add a peer-reviewed publication to their CVs. Invitation is by faculty nomination only. To maintain *Oxford Bibliographies*'s high standard of quality, this award will feature a rigorous selection and approval process. Contracts will only be offered to authors whose proposals demonstrate scholarly excellence, strong command of the literature, and are directly relevant to *Oxford Bibliographies*. Rigorous quality controls such as external peer review and editorial board approval will permit only the highest quality contributions to reach publication.

The Nomination Process:

Faculty can nominate as many students as they would like as long as the nominees are well advanced in the dissertation writing process. They should be far enough along in their work to be able demonstrate a strong command of the literature in their area of expertise. We do not accept nominations of master's students or students that are still at the dissertation proposal stage. Nominations are subject to approval by the editorial team at Oxford University Press.

The Application:

Nominees will be asked to send in their curriculum vitae, a sample chapter from their dissertation, a copy of their dissertation's bibliography, and the names of their dissertation committee members or external examiners, if known. Nominees will also be asked to include a 750-word statement about their proposed Oxford Bibliographies contribution identifying the literature which will be discussed. If accepted for contract, the proposal statement will serve as a starting point for determining, with the editorial team, the exact focus of the nominee's contribution.

Selection and Approval for Publication:

The Oxford Bibliographies editorial team in conjunction with the editor-in-chief and advisory editors of the subject area for which the student was nominated will review the proposals. Proposals will be evaluated based on the following criteria: strong writing skills, demonstration of scholarly excellence, command of the literature, and concision of writing style. Contracts will only be offered to authors of proposals that meet the above criteria and are of direct relevance to Oxford Bibliographies content plans.
