# Professional indemnity what does it mean for you?

All registrants (other than social workers in England) must now have a professional indemnity arrangement in place as a condition of their registration.

This arrangement must provide appropriate cover for all aspects of their professional practice. This includes their main employment, but also any private or voluntary work they do.

'Graduates that are not yet employed or have an arrangement in place will still be able to apply for registration.'

It is important to remember that most registrants will already meet this requirement and will not need to take further action.



From April 2015, applicants applying for registration and renewal will be asked to complete a declaration to say that they understand this requirement.

## How are education providers affected?

Teaching staff that supervise students need to make sure that their arrangement applies to all of their practice. Many registrants working in the education sector will also be employed by the NHS so they will already have this in place. Students are not legally required to have an arrangement. Graduates that are not yet employed or have an arrangement in place will still be able to apply for registration.

## Investigating programme concerns – six things you should know

Anyone can raise a concern with the HCPC about an approved programme of study. Here are six things you should know about the process and how it could affect you.

- 1 We investigate once your own internal investigations have concluded.
- 2 We look at concerns that may impact our standards. We do not make academic or professional judgements, or overturn any decisions you have made.




- 3 We ask for your views on the concern and remain confidential at all times.
- 4 We may decide to review your programme as a result.
- 5 You are responsible for making your students, placement educators and service users aware that they can raise a concern.
- 6 On average, less than one per cent of approved programmes are subject to a concern investigation each year.



# Reports review social work, AMHP and independent prescribing programmes

We have produced three new reports that highlight key findings following approval visits to education providers of:

- social work programmes in England;
- approved mental health professional (AMHP) programmes; and
- independent prescribing (IP) programmes.



The reports have taught us a lot about our new professions and post-registration areas of practice, and how they meet our standards. They will inform our research into further prescribing entitlements and final year assessments for social work and AMHP programmes.

# Council member's comment

### Approval visits

Council members Robert Templeton and Joy Tweed joined us on visits to the University of Greenwich and Birmingham City University, to see the approval process in action first-hand.

Visits assess whether new programmes, or those with significant changes, meet our standards. Robert and Joy were keen to see how their decisions, such as the new service user and carer involvement standard and introduction of lay visitors, impact on the process.

"What struck me was the thoroughness of the process. The emphasis was to ensure the student and service user and carer voice was clearly heard, and that the education provider comprehensively reviewed and improved its programme."

## Joy Tweed, lay member of the Council and Chair of the Education and Training Committee.

"I could see what a valuable perspective lay visitors, who are not from one of the professions we regulate, bring to the process. The visit also gave me food for thought as we begin to think about renewing our education standards."

# Removed a student from your programme?

If this is due to an issue of misconduct and you know the student could apply for registration in the future by completing a different programme, here are some things to consider.

### Should you notify the HCPC?

In most cases, no. If an individual's misconduct can be addressed through reflection, learning and further training, it is not likely you would need to raise it with us. Broadly speaking, only offences of a sexual nature, violence or dishonesty would be cause for concern.

#### The watch list

You should only contact us in cases of serious misconduct. An individual placed on the watch list will be subject to further review should they ever apply for registration with us. Dushyan Ashton, Registrations Manager, explains more.



"It is important to remember that just because an individual is on the watch list, it doesn't mean they will be refused registration.

We would carefully consider if their character has been affected. Very few applications are unsuccessful due to character related issues."
