By strengthening the tenure-track professorship, Universität Hamburg has introduced a new career opportunity for young researchers.

Due to the success of the tenure-track program established by the Federal Ministry of Education and Research, Universität Hamburg is inviting applications for the following tenure-track position in the key research area **Climate, Earth and Environment**:

TENURE-TRACK PROFESSORSHIP (W1 TENURE-TRACK LEADING TO A W2) FOR POLITICAL SCIENCE WITH A FOCUS ON GLOBALISATION AND GOVERNANCE IN CLIMATE POLICY

commencing as soon as possible, ref. no. JP 271.

Responsibilities:

The successful candidate will conduct research and teach in the field of globalisation and governance in climate policy. The successful applicant will focus on international and comparative climate policy in political science research. We expect the successful candidate to cooperate within the key research area *Climate, Earth and Environment*, publish his or her research widely, and demonstrate willingness to acquire external funding. Potential for connectivity with the University's area of potential *Globalisation and its Consequences* and cooperation with the Center for Globalisation and Governance (CGG) is desirable.

We further expect the successful candidate to offer both English- and German-language courses in the Faculty's bachelor's and master's degree programs, in particular within the political science and the Faculty's Graduate School. Willingness to participate in the interdisciplinary MSc in *Politics, Economics and Philosophy* is highly desirable.

The successful candidate is further expected to participate actively in the instruction of students pursuing a teaching degree in the respective discipline.

Section 12 subsection 7 sentence 2 of the Hamburg higher education act (Hamburgisches Hochschulgesetz, HmbHG) applies.

Requirements:

Academic qualifications and additional requirements as specified in Section 18 HmbHG.

Further criteria:

Applicants are expected to have international research experience as well as a successful track record in acquiring external funding and carrying out externally funded projects. The University

places particular emphasis on the quality of teaching and therefore requests that applicants provide details of their teaching experience and objectives.

The post holder is expected to acquire the language skills necessary to teach in German (Level C1 of the Common European Framework of Reference for Languages) within two years of commencing employment providing he or she does not have the requisite skills when starting.

A tenure-track evaluation will be conducted during the second phase of the junior professorship in order to determine whether requirements for appointment to a W2 professorship have been met. Section 15 HmbHG applies. Upon proof that the candidate fulfills the requirements for an appointment to a W2 professorship, he or she is eligible for a tenured professorship. The regulations prohibiting internal appointments (*Hausberufungsverbot*) also apply to this junior professorship.

In accordance with Section 14 subsection 3 sentence 3 HmbHG, Universität Hamburg seeks to increase the proportion of women in teaching and research and encourages female academics to apply.

Qualified disabled candidates or applicants with equivalent status receive preference in the application process.
