Keynote speaker: Professor Deborah Lupton (Centenary Research Professor, University of Canberra)

Keynote Title: The More-than-Human Worlds of Self-Tracking for Health and Fitness

Sociology of Sport, like its parent discipline Sociology and the Social Sciences more broadly, is facing unprecedented challenges not only over funding and resources, but also in terms of its legitimacy and relevance. Within the context of neoliberalism in general, and the corporatisation of university education in particular, there has been a slow but steady marginalisation of sociology of sport as a field of academic study. Curiously this has occurred despite enormous growth in the interest in 'sport' (broadly defined) within the global economy and as a focus of scholarly enquiry. Both the state and private interests are increasingly aware of sports' strategic location at the intersection of key sectors of society including: education, health, business and tourism/nation branding. Moreover, scholars spanning the fields of sociology, anthropology, history, geography, politics, economics, media and communication studies, and gender studies are increasingly recognising the social significance of sport as a cultural form and practice.

As we approach the 20th year of the new millennium, the 2019 World Congress of Sociology of Sport provides an ideal platform to reflect, evaluate and contemplate the past, present and future of the field. While the sociology of sport, across all of its specialisations, has successfully

identified social fault lines within sport, discussions about how to use this knowledge for social transformation and social justice through collective action and social policy have been far less robust. In short, it is timely for our field to envision and create an alternative future for both sport and its sociological analysis.

The 2019 Congress offers a unique opportunity to consider how, in the spirit of C. Wright Mills, our research, teaching, public service and political activism, can connect private experience with wider social structures, personal problems with public issues, and scientific analysis with political awareness. We invite scholars to share their research and to consider how it might contribute to a new vision for sport, exercise, physical activity and health.

The 14 sessions (13 scientific and 1 business meeting) were well attended during the week with between 20 to 36 members involved at any one time. Call for Research Articles

The *IRSS* encourages the submission of diverse research articles seated in the sociology of sport, broadly defined that shed light on social and cultural understandings of sport. Interdisciplinary, inclusive, and global, the *IRSS* is the journal of the International Sociology of Sport Association



and is published in partnership with SAGE Publications. Please visit the journal website for more information about its Aims & Scope, the Editorial Board, manuscript submission guidelines, and sample issues at <u>http://journals.sagepub.com/home/irs</u>

The IRSS publishes eight issues each year. To help expedite the review and publication process, the IRSS uses the SAGE Track online manuscript submission site powered by ScholarOne Manuscripts. Scholars submitting manuscripts for consideration can expect a prompt double blind review process that draws on the expertise of a diverse editorial board and a worldwide network over 3000 expert area scholars. While we expect in the region of 300 submissions per year (including revised manuscripts) we operate a highly efficient process such that the majority of decisions are on manuscripts are issued within 40 days of submission. The journal's use of the SAGE OnlineFirst publication program means that accepted manuscripts are usually made available to the scholarly community within weeks of acceptance. New Content alerts and

exposure on the Sage Sociology Twitter channel (with around 34,000 followers) means that publication in the *IRSS* provides authors with an excellent opportunity to get scholarly work promptly disseminated to international audiences.

The release of the 2017 Impact Factors showed how the journal has consolidated its position in the field in recent years. The IRSS Impact Factor is at an all-time high of 1.914, and the IRSS is now ranked 28/50 in the Hospitality, Leisure, Sport & Tourism JCR category, and 33/146 in the Sociology category, in the Social Science Citation Index.

About IRSS Book and Media Reviews

The IRSS publishes reviews of books or media to provide a scholarly assessment of key works that may advance understanding of sport in social and cultural contexts. Currently the IRSS published approximately 12 reviews per year. Most often these are an assessment of a single work, but comparative assessments of more than one work within a more substantial integrative essay are equally welcome. Authors interested in contributing a book or media review symposium (in which the same work is reviewed by 2 or 3 different reviewers) are encouraged to contact the Book/Media Review Editor directly.

Reviews published in the IRSS do not require an abstract or key words. Book or Media Reviews should contain a heading that includes the Book or Media Title, Author, Publisher's Name and Location, Date of Publication, Number of Pages (or running length), ISBN Number (for books) and eBook Number (if appropriate). Book or Media Review authors may refer to previous issues of IRSS for format guidance.

CALL FOR PAPERS ISSA Graduate Paper Award 2019

The 2019 ISSA Graduate Paper Award is co-sponsored by ISSA and SAGE

Description: The aim of the International Sociology of Sport Association's (ISSA) Graduate Paper Award is to recognize the scholarship of outstanding graduate students in the international community of sociology of sport. The award will be granted to a scholarly paper, authored by a graduate student, which is deemed by a panel of judges to demonstrate considerable originality, critical and analytical ability, and to be of the highest quality from among those submitted¹. The winning author will be invited to receive the award and present or distribute the paper at the annual conference of the ISSA. Eligibility:

- The student must be registered for masters or doctoral level graduate work at the time her or his paper is submitted.
- It must be a single-authored paper.
- The student must be a member of ISSA at the time her or his paper is submitted.
- The committee will accept only one submission per author.
- Previous winners are not eligible.
- A paper cannot be considered for the ISSA GPA award at the same time that it is submitted for another award.
- A paper that won a previous award cannot be submitted to the ISSA GPA.

Award:

- The winning author will be invited to present or distribute the paper at the *ISSA World Congress of the Sociology of Sport* in Dunedin, University of Otago, New Zealand, 24-27 April 2019. While the registration fees for the winner are included in the prize, participation in the 2019 Congress is not mandatory.
- The winning author will receive an ISSA sponsored prize of membership in ISSA for 12 months.
- The winning author will receive a SAGE Publisher sponsored prize of £150 worth of books.
- The panel of judges may also give up to two honourable mentions. Graduate students receiving honourable mentions will also have their papers accepted for presentation or distribution at the ISSA conference.
- The name of all winning authors will be posted on the ISSA website (see, www.issa1965.org/awards).

Requirements:

- Candidates are to submit a 3000-6000 word (excluding references) scholarly paper on a topic that is of interest to the international sociology of sport academic community.
- Papers with a text of over 6000 words will not be considered.
- Authors are to submit a cover page that contains the title of the paper and the full contact information of the author.
- The author's identity must not be recognizable in the text.
- Authors must be graduate students at the time the paper is submitted.
- Authors must be members of ISSA at the time the paper is submitted.
- Authors are to submit a letter, signed by her or his academic advisor, verifying graduate student status.
- Authors are to follow a style consistent with the publication guidelines for the International Review for the Sociology of Sport.
- Papers should be submitted electronically (in Microsoft Word format attachment) to the Awards Committee Chair, Cora Burnett. All papers should be emailed **to** awards@issa1965.org.

Deadline for Receipt of Submissions: December 31, 2018.

The winner will be announced by March 1, 2019.

The Summit on Communication and Sport welcomes submissions from all methodological and theoretical perspectives.

The 2019 conference theme is "Blazing the Trail Forward" and we encourage you to submit papers that confirm, question, or critique the theme in relation to the role of sport communication in a time of political, global, cultural, economic, and technological change. Evaluation: All submissions will be evaluated through a blind peer review process. Decision Deadline: Author(s) of accepted submissions will receive email notification no later than Friday, December 14, 2018. Author Limits: A maximum of two (2) first-authored submissions from a single author will be considered for presentation. First authors will be used for paneling purposes and are required to lead the presentation of the work.

Panel Information: Research and panel sessions are one hour and fifteen minutes long. Research sessions will be constructed to allow for at least 15 minutes of discussion following the presentations. Scholars interested in submitting to the 2019 Summit have two options: (1) an extended abstract submission; or (2) a panel discussion submission.

Abstract submissions may not exceed 1000 words (excluding references) in length and should be prepared for blind review (clear of any identifying information about the author(s). Panel discussions must focus on an interactive discussion format, with a clearly defined theme.

Submissions must include a title, a description of up to 500 words explaining the focus and rationale, and a list of all panelists' institutional or professional affiliations.

Top Student Paper

• IACS will recognize the Top Student Paper submitted to the Summit. For award consideration, a full-length manuscript must be submitted to the review committee by Thursday, February 28th, 2019. Students may submit an abstract of their work at the October deadline (and this is highly encouraged) though this will not be a requirement. Recognition of Top Student Paper will be determined by blind review of the submission.

Review Information

- **NEW FOR 2019**: We will be going back to one extended abstract submission there will not be separate review criteria for works-in-progress and completed papers. All should be submitted as extended abstracts, and will be judged using the same criteria.
- Reviewers will be selected from self-nomination through the submission process. Reviewers must have at minimum a completed Master's degree in a field associated with the focus of IACS. Introduction

Sport coaches are one of the most visible, powerful, popular and (in some cases) lucrative occupations in the U.S., and arguably around the world. Statistically men dominate coaching positions in a majority of countries, levels, and sports and a large body of research over the last three decades has documented the factors that influence this phenomena. With the publication of LaVoi and Dutove's (2012) ecological model of barriers and supports for women coaches and a distillation of current intersectional work within Women in Sports Coaching (LaVoi, 2016), an increasing focus in research into the psychology of the sports coach (e.g., Mallett & Lara-Bercial, 2016; Thelwell, Harwood, & Greenlees, 2016), and high profile legal cases of women coaches' gender discrimination lawsuits, coupled with the #MeToo movement, experiences of women in the workplace has taken center stage, including women sport coaches. The end goal of this special issue, therefore, is to highlight new research, interventions, advocacy and policy implementation that fill gaps in knowledge to shift the percentage of women coaches out of its current stagnation, and improve workplace and psychosocial outcomes for women in the coaching profession.

This work could include:

- Experiences of women in sport coaching
 - Career trajectories of successful and veteran women coaches
 - o Strategies women coaches have used to remain in the profession

- Importance and/or impact of women in coaching (i.e., role models, mentorship, outcomes for athletes, workplace influence)

- Experiences of women navigating intersectionality identities and power
- Media portrayals of and narratives about women sport coaches

- Documenting, challenging or confirming narratives about women coaches
- Extension of research around barriers for women in coaching
- Changing the occupational landscape to value and support women
 - Implicit bias within interactions with administrators, colleagues, and athletes
 - Best practices of recruitment, hiring and retaining women coaches
 - Departmental/organizational culture change
 - Fighting and resisting bias
 - Advancement opportunities for women sport coaches in systems of established patriarchy and hierarchies
 - o Pathways for advancement into administration
 - Pay and resource equity for women coaches
- Filling the pipeline of women in coaching
 - Successful models, programs or initiatives that have encouraged girls and women to pursue coaching
 - Models and best practices for improving workplaces for women in coaching

In line with the scope of WSPAJ, an essential element of any submitted manuscript should be to further thought, theory, and research on women in sport. We are particularly interested in articles that further advocacy, thought, theory, and research on women sport coaches. To that end, we welcome qualitative, quantitative and mixed method research submissions that address the pertinent issues summarized above on women's sport coaching experiences. The submissions can take the following form:

- Empirical, data-driven studies focused on varied methodologies and/or theories
- Theoretical papers or literature reviews related to a particular topic from a variety of perspectives (e.g., historical, sociological, psychological, etc.)
- Practical articles that identify strategies or best practices
- Commentaries of best practices in advocacy, policy development, education and networking

Job description: We are looking for two highly motivated PhD Candidates who wish to conduct their PhD research in the context of a research project funded by the Netherlands Organisation for Scientific Research (NWO) entitled How racist is televised football and do audiences react?

Project description: Televised men's football (soccer) is one of the most visibly mixed ethnic cultural practices. Despite the alleged social function of football as a uniting social force, numerous studies have also shown how football journalists incorporate racial/ethnic stereotypes in their commentary associating Black footballers with bodily, athletic qualities but not with domains that require intelligence. It remains unknown, though, how these discourses come about. We therefore need to shift the research-focus towards the - mainly White - journalists who produce the football coverage. The research question guiding the project is: How do discourses of race/ethnicity play a role in televised football production and how are these discourses articulated at the nexus of televised football content and audience receptions? The study will be conducted across four European countries: Poland, Spain, England, and the Netherlands. We look for 1) a PhD candidate who will explore meanings given to race/ethnicity in men's televised football in Spain and 2) a PhD candidate who will explore meanings given to race/ethnicity in men's televised football in Poland. Data collection will combine content analyses of football screenings with individual interviews, focus group interviews, and participant observations, amongst football journalists and televised football audiences. The project will be informed theoretically by insights from sociology of sport, cultural studies and whiteness studies, amongst other things.

The candidates will be appointed for a period of four years. They will be located in Rotterdam but an important part of the data collection will take place in either Spain or Poland.

How to apply: Your application letter should be accompanied by a concise research proposal of no more than 750 words, in which you explain what you consider to be the most pressing issues in the study of televised football in relation to race/ethnicity, in either Poland or Spain (depending on your preferred PhD position), along with corresponding research questions.
